- All mooring permits expire on May 31st. Renewal applications will be mailed to you at the address provided above. Renewal form and fee must be received by June 1st or a late fee will be assessed. Moorings not re-registered by September 1st will be considered abandoned, cut loose or removed and their location reassigned unless prior arrangements have been made with the Harbor Master.
- Location of NEW moorings will be assigned by the Harbor Master.
- Holder of permit is responsible for his/her mooring and making adjustments, as required, for the safety of this boat and adjacent boats.
- Moorings must be inspected every two years or permit will not be renewed. Proof of inspection is required.
- **Proof of liability insurance is required for all new and renewed mooring permits.**
